

GENERAL INFORMATION AND TOUR CONDITIONS

DEPOSIT AND PAYMENTS:

Your reservation deposit of \$250 per person (\$175 per person in nonrefundable) is official upon receiving your credit card number and information or check. The payment schedule is as follows:

- \$250 initial deposit due at time of reservation
- 2nd deposit of 50% of balance due on November 27, 2006
- Final payment of balance due on February 12, 2007

CRUISE FARE:

Rates are per person based on double occupancy and include the 4 night cruise fare, meals on board ship, entertainment and all concert activities. The cost of the third, fourth and fifth passengers sharing a stateroom with two adults will be \$499 per person.

CANCELLATIONS:

All cancellation requests must be submitted in writing and addressed to Cruise Connections. Failure to appear for embarkation for any reason constitutes a cancellation subject to full penalties. Cancellation penalties will be charged as follows:

- Deposit until Feb. 12 \$175 per person
- Feb. 13 until March 13 50% of Cruise Fair
- March 14 until sailing 100% of Cruise Fair
- No refund for no shows or when cancelled after March 13, 2007. Airline ticket cancellation is subject to the cancellation policy of the specific airline. In most cases tickets are non-refundable. Trip cancellation insurance is highly recommended.

EMBARKATION:

The ms Sovereign of the Seas will be at Port Canaveral Monday June 4, 2007. Embarkation will begin at 12:00pm as the ship will sail at 4:00pm. You must be on board no later than 3:30pm.

IMMIGRATION:

U.S. and Canadian citizens must carry a passport. A Birth Certificate or Social Security card are not acceptable as proof of citizenship. Aliens who are permanent residents must have their Alien Registration Card and passport. All of the non-U.S. passengers should contact their respective embassies or U.S. Immigrations for applicable regulations. Boarding will be denied to those without proper documentation.

NOT INCLUDED:

Transportation, transfers, optional cancellation insurance, shore excursions, any items of a personal nature such as laundry, telephone calls, and beverages not on the menu (sodas, bottle water, etc.) Port Charges and Gratuities of \$175 per person. Port Charges are comprised of U.S. Customs Fees, International Departure Taxes, and Non-Commissionable cruise line charges (government fees are subject to change). Gratuities are prepaid to your cabin steward, waiter and busboy. Taxes, fuel charges and fees are subject to change. In the event of an increase in fuel cost, a surcharge will be applied to your sail and sign account.

ADVANCES OR DELAYED SAILINGS:

In the event of strike, lockouts, riots or stoppage of labor from whatever causes, or for any other reason whatsoever beyond the control of PraiseFest Ministries, Cruise Connections, Christian Travel Finder or Royal Caribbean, Royal Caribbean in its sole discretion may cancel, advance or postpone any scheduled sailing or call at any port and may (but is not obligated to) substitute another vessel, and neither PraiseFest Ministries, Cruise Connections, Christian Travel Finder nor Royal Caribbean shall be liable for any loss whatsoever to passengers by reason of such cancellation, advancement, postponement or substitution.
